#### **SUMMARY**

Council to approve a tender for the supply of gravel production at Currie's pit on Garmony Road Narembeen.

#### **BACKGROUND**

The Shire of Narembeen Roadworks Delivery Program for 2020/2021 for the Merredin-Narembeen Road Secondary Freight Route projects requires the sourcing and production of suitable quality pavement gravel materials. The total quantity required is approximately 25,000m3 in stockpile. Tenders closing on the 1 September have been called for gravel production at Currie's Pit near the intersection of Garmony Road and the Merredin-Narembeen Road.

Given the timeframes associated with this project, tenders have been called to allow this project to proceed within the expected timeframes.

The scope of the services included the following:

- Mobilisation of all necessary labour, plant and equipment.
- Push up operations using a suitable sized bulldozer.
- Crushing and screening the gravel to meet base course quality specifications.

The royalty payable to the landowner was not included and the Shire will pay this cost direct as per Council policy.

#### COMMENT

Tenders closed on September 1st 2020. The following tenders were received:-

B & J Catalano Pty Ltd \$333,000 GST ExcVernice Pty Ltd \$384,000 GST Exc

Charles Hull Contracting declined to provide a quotation. B & J Catalano and the Vernice Pty Ltd quotations were reviewed and assessed with the assistance of SMEC.

B & J Catalano did place a qualification on their tender due to the exact nature of the material in situ being unknown they could not guarantee that the end product will conform to the specification. This seems reasonable given the circumstances. All the testing indicates that the product will be of a good standard.

Both companies met the requirements for works experience and company track record. Based on value for money, it is recommended that the supply of gravel production be awarded to B & J Catalano Pty Ltd. They have submitted the lowest price and have considerable experience performing this type of work.

Note councillors inspected the site on a recent road inspection and the process for gravel production was discussed.

#### STATUTORY IMPLICATIONS

Local Government Act 1995

- 3.57. Tenders for providing goods or services
- (1) A local government is required to invite tenders before it enters into a contract of a prescribed kind under which another person is to supply goods or services.
- (2) Regulations may make provision about tenders.

Local Government (Function & General) Regulations 1996

- 11. When tenders have to be publicly invited
- (1) Tenders are to be publicly invited according to the requirements of this Division before a local government enters into a contract for another person to supply goods or services if the consideration under the contract is, or is expected to be, more, or worth more, than \$150 000 unless sub regulation (2) states otherwise.
- (2) Tenders do not have to be publicly invited according to the requirements of this Division if —
- (a) the supply of the goods or services is to be obtained from expenditure authorised in an emergency under section 6.8(1) (c) of the Act; or
- (b) the supply of the goods or services is to be obtained through the WALGA Preferred Supplier Program.

Note the tender threshold has being raised to \$250,000 by the State Government.
