Council to appoint representatives to committees and working groups following the 2025 Local Government Election.

Background

Council reviews its representation on Committees of Council, Regional Groups, Community Groups, and Working Groups every two years following each election cycle.

Councillor representation across these groups ensures effective governance, collaboration, community consultation, and advocacy.

Comment

Committees of Council	
Audit, Risk and Improvement Committee	This committee meets at least twice a year and is generally held before an Ordinary Meeting of Council. The purpose of this committee is to oversee risk management, internal control, legislative compliance, and external audit processes. This includes acceptance of the auditors' statements and management reports. To fulfil its functions under regulation 16(c) of the <i>Local Government (Audit) Regulations 1996</i> , the Audit, Risk and Improvement Committee report directs to Council This committee requires an independent chairperson and an independent deputy to the chair and is comprised of all Councillors.

Behaviour Complaints Committee	The Behaviour Complaints Committee provides an avenue for complaints about Council Members, Committee Members and Candidates' behaviour to be brought forward, reviewed and assessed in a fair, consistent and equitable manner by Council.
Local Emergency Management Committee (LEMC)	The purpose of the LEMC is to provide advice and assist in the establishment, development, review and testing of local emergency management arrangements and to carry out emergency management activities as directed by State Emergency Management Committee or prescribed by regulations. This group meets quarterly.
Narembeen Bushfire Advisory Committee/Volunteer Fire Brigade	This committee advises Council on all matters relating to bushfire control including the management of bushfire brigades and coordination of prevention, preparation, and response strategies.
Plant and Works Committee	This committee, discusses and makes recommendations to Council for regarding its plant replacement strategy and reviews and provides recommendations for budgeted acquisitions with a value between \$150,001 and \$249,999 (ex-GST).
Regional Groups	
Central East Aged Care Alliance (CEACA)	CEACA is a partnership of local governments in the Wheatbelt established to plan, advocate, and deliver sustainable aged care and independent living options that enable residents to age within their communities. The Management Committee provides governance and oversight of CEACA's strategic direction, finances, and project delivery, ensuring alignment with regional priorities and legislative requirements. Each member Shire appoints a council delegate to represent its interests, participate in decision-making, and report back to Council, while the CEO supports the delegate through advice, coordination, and collaboration with CEACA's executive to ensure effective communication and implementation of Council decisions.
Eastern Wheatbelt Biosecurity Group	The objects of the association are to limit the impacts of pest animals and pest plant species within Eastern Wheatbelt communities by initiating, promoting and fostering the control of pests on all classes of land in the area, and encouraging landholders, land managers and other persons to adopt sound pest management practices on all classes of land throughout the area.
Great Eastern Country Zone (GECZ)	GECZ of WALGA provides a forum for member local governments to collaborate, discuss, and advocate on regional and state issues affecting the Eastern Wheatbelt region. It enables Councils to provide coordinated input into WALGA policy development and influence decisions at a higher level of government. The Shire of Narembeen is represented by the Shire President and Deputy Shire

	President, ensuring that local perspectives are voiced in regional discussions. A proxy representative is also appointed to attend meetings when either delegate is unavailable, ensuring consistent participation and representation of the Shire's interests.
Roe Regional Organisation of Councils (RoeROC)	RoeROC is a collaboration between the Shires of Narembeen, Corrigin, Kondinin, and Kulin, established through a Memorandum of Understanding (MOU) and guided by operational guidelines to promote regional cooperation and efficiency. The group focuses on strategic projects of regional significance, including the shared delivery of health services and joint management of the Bendering Waste Management Facility, while also exploring opportunities for resource sharing and joint advocacy. RoeROC is supported by an Executive Officer who coordinates meetings, reporting, and project implementation. The Shire President and Deputy Shire President represent Narembeen on the committee, with a proxy appointed to ensure continuity of representation when required.
Roe Sub-Group Regional Roads Group (RRG)	The RRG is a focused working group that operates under the broader Wheatbelt South Regional Road Group (WSRRG) framework. Its primary purpose is to coordinate, assess, and prioritise road funding and infrastructure projects within the subregion to ensure equitable distribution of resources and alignment with regional transport priorities. The subgroup provides a platform for member local governments to collaborate on planning, maintenance, and improvement of local and regional road networks, share technical expertise, and advocate collectively for funding through the State Road Funds to Local Government Agreement. It plays a key role in ensuring that road projects across the region are strategically aligned, cost-effective, and support regional connectivity and safety.
Roe Tourism	Roe Tourism is a not-for-profit incorporated community tourism group incorporating six Shires of the Roe district – Corrigin, Kulin, Kondinin, Lake Grace, Narembeen, Beverley, Bruce Rock and Quairading. Roe Tourism is a tourism marketing body for the Pathways to Wave Rock self-drive route, which includes the iconic and internally recognised Wave Rock.
Rural Water Council WA (Inc)	Promotes water issues in rural areas, including awareness, representation to Government Department and works collaboratively with Water Corporation, DWER and WDC.
Wheatbelt South Regional Road Group	The WSRRG is a key advisory body established under the State Road Funds to Local Government Agreement, bringing together local governments, Main Roads WA, and WALGA to plan and prioritise investment in the regional road network. The group oversees the allocation of road funding, reviews project submissions, and ensures that transport

	infrastructure across the Wheatbelt South region supports economic development, safety, and connectivity. The Shire President has historically represented the Shire of Narembeen on this group, advocating for local priorities and ensuring that Narembeen's regional road needs are effectively considered within broader planning and funding decisions.
Community Groups	
Community Shed	The community shed incorporates both the Men's Shed and the community space for Arts and Crafts.
Go Narembeen	Go Narembeen is Narembeen's Progress Association.
Historical Society	The Narembeen Historical Society works to preserve, collect, research and interpret historical information and items.
School Parents and Citizens	Representation on the P&C continues to strengthen our relationship with the school.
St John Ambulance	St John volunteers provide first aid services, training, and equipment for our local community.
Narembeen Town Team	The Shire works collaboratively with the Town Team to enhance community engagement through placemaking and space activation initiatives. This partnership supports community-led projects that transform public spaces into vibrant, welcoming areas that reflect Narembeen's character and spirit.
Narembeen Community Wellbeing	The Narembeen Community Wellbeing Plan seeks to build resilience, improve health and wellbeing and strengthen agency collaboration; in turn reducing the incidence of risky behaviours and potential harms associated with alcohol and other drug use within the community of Narembeen.
Narembeen Aged Homes Management Committee	Narembeen Aged Homes Inc provides housing and support services to the elderly in Narembeen.

Shire of Narembeen, Ramelius Resources, Go Narembeen Community Benefit Fund Advisory Committee	Administered by the Shire of Narembeen, the Advisory Committee—comprising representatives from Go Narembeen, Ramelius Resources, and the Shire—reviews community grant applications and makes recommendations to Council on funding allocations. The purpose of the Community Benefit Fund process is to ensure community funds are distributed fairly and transparently to projects that enhance local wellbeing, support volunteer and sporting groups, and strengthen the social and cultural development of Narembeen.
Local Skeleton Weed Advisory Committee (External)	The Local Action Group assists its members in meeting all lawful obligations under the <i>Biosecurity and Agriculture Management Act 2007</i> and associated Regulations 2011, by identifying and treating the invasive weed, Skeleton Weed.

Statutory Implications

Local Government Act 1995

Section 5.8 – Establishment of committees

A local government may establish* committees of 3 or more persons to assist the council and to exercise the powers and discharge the duties of the local government that can be delegated to committees.

* Absolute majority required

Section 5.10 - Committee members, appointment of

- (1) A committee is to have as its members
 - (a) persons appointed* by the local government to be members of the committee (other than those referred to in paragraph (b)); and
 - (b) persons who are appointed to be members of the committee under subsection (4) or (5).
- * Absolute majority required.
- (2) At any given time each council member is entitled to be a member of at least one committee referred to in section 5.9(2)(a) or (b) and if a council member nominates himself or herself to be a member of such a committee or committees, the local government is to include that council member in the persons appointed under subsection (1)(a) to at least one of those committees as the local government decides.
- (3) Section 52 of the *Interpretation Act 1984* applies to appointments of committee members other than those appointed under subsection (4) or (5) but any power exercised under section 52(1) of that Act can only be exercised on the decision of an absolute majority of the council.
- (4) If at a meeting of the council a local government is to make an appointment to a committee that has or could have a council member as a member and the mayor or president informs the local government of his or her wish to be a member of the committee, the local government is to appoint the mayor or president to be a member of the committee.
- (5) If at a meeting of the council a local government is to make an appointment to a committee that has or will have an employee as a member and the CEO informs the local government of his or her wish (a) to be a member of the committee; or (b) that a representative of the CEO be a member of the committee, the local government is to appoint the CEO or the CEO's representative, as the case may be, to be a member of the committee.

Local Government Act Section 5.11 – Deputy committee members

5.11A. Deputy committee members

- (1) The local government may appoint* a person to be a deputy of a member of a committee and may terminate such an appointment* at any time.
- * Absolute majority required.
- (3) A deputy of a member of a committee may perform the functions of the member when the member is unable to do so by reason of illness, absence or other cause.
- (4) A deputy of a member of a committee, while acting as a member, has all the functions of and all the protection given to a member. [Section 5.11A inserted by No. 17 of 2009 s. 20.]
- 5.11. Committee membership, tenure of
- (1) Where a person is appointed as a member of a committee under section 5.10(4) or (5), the person's membership of the committee continues until
 - (a) the person no longer holds the office by virtue of which the person became a member, or is no longer the CEO, or the CEO's representative, as the case may be; or
 - (b) the person resigns from membership of the committee; or
 - (c) the committee is disbanded; or (d) the next ordinary elections day, whichever happens first.
- (2) Where a person is appointed as a member of a committee other than under section 5.10(4) or (5), the person's membership of the committee continues until
 - (a) the term of the person's appointment as a committee member expires; or
 - (b) the local government removes the person from the office of committee member or the office of committee member otherwise becomes vacant; or
 - (c) the committee is disbanded; or (d) the next ordinary elections day, whichever happens first.

Bush Fires Act 1954

- 67. Advisory committees (1) A local government may at any time appoint such persons as it thinks fit as a bush fire advisory committee for the purpose of advising the local government regarding all matters relating to the preventing, controlling and extinguishing of bush fires, the planning of the layout of fire-breaks in the district, prosecutions for breaches of this Act, the formation of bush fire brigades and the grouping thereof under group brigade officers, the ensuring of co-operation and co-ordination of bush fire brigades in their efforts and activities, and any other matter relating to bush fire control whether of the same kind as, or a different kind from, those specified in this subsection.
- (2) A committee appointed under this section shall include a member of the council of the local government nominated by it for that purpose as a member of the committee, and the committee shall elect one of their number to be chairman thereof.

Following the Local Government Elections and the change in Councillors, the Development Assessment Panel representative members must be reviewed.

Council must nominate two members and two alternate members to the Development Assessment Panel (DAP).

Background

As a key component of planning reform in Western Australia, Development Assessment Panels (DAPs) are intended to enhance planning expertise in decision making by improving the balance between technical advice and local knowledge.

Each Development Assessment Panel comprises five (5) members – three (3) specialist members, including the presiding member and two local government members.

Development Assessment Panels (DAP's) were introduced on 1 July 2011 to determine development applications that met prescribed criteria.

Council has nominated the following Councillors as its DAP members, for a term ending 26 January 2026:

- DAP Local Government Members Cr H Cusack and Cr S Stirrat
- DAP Local Government Alternate Members Cr W Milner and Cr C Bray

The Development Assessment Panel has requested that Council nominate four Council members for the next two-year term, ending on 26 January 2028, by 21 November 2025. Details of DAPS is as follows:

Mandatory DAP Applications

These are development applications which must be determined by a Development Assessment Panel and cannot be determined by a local government of the Western Australian Planning Commission. Mandatory applications must meet the following value thresholds:-

DAP	Mandatory value threshold
City of Perth	\$20 million or more
Rest of the State	\$10 million or more

Optional "Opt-in" DAP Applications

These are development applications where the applicant may choose to have the application determined by a Development Assessment Panel, or by the local government or Western Australian Planning Commission under the normal process. To be considered for an "opt-in" application, the application must fit within the following value thresholds:-

DAP	Mandatory value threshold
City of Perth	Between \$2 million - \$20 million
Rest of the State	Between \$2 million - \$10 million

Narembeen is part of the Mid-West/Wheatbelt Development Assessment Panel.

Comment

Following the following the completion of the term, there will be four vacancies to be filled for Narembeen's DAP membership.

Representation of local interests is a key aspect of the DAP system. Under regulation 24 of the Planning and Development (Development Assessment Panels) Regulations 2011 (the Regulations), Council is requested to nominate as soon as possible following the elections, four elected council members to sit as DAP members for the Shire of Narembeen.

All Development Assessment Panel (DAP) members, including elected members, are required to complete mandatory online training provided by the Department of Planning, Lands and Heritage (DPLH) prior to appointment. The self-paced course (approximately 3–4 hours) covers the DAP framework, roles and responsibilities, decision-making processes, and conflict-of-interest requirements. Participants must successfully complete an online assessment to receive certification, which is valid for their term of appointment. The training is free of charge and accessed via the DPLH eLearning platform once nominations are confirmed.

For Council to nominate two voting delegates to the Great Eastern Country Zone (GECZ).

Background

The governance structure of WALGA is designed to ensure it is representative of all 139 Member Local Governments.

Zones are autonomous groupings of geographically aligned Local Governments. The key functions of Zones are to elect one or more representative to State Council, consider the State Council Agenda and provide direction and feedback to State Council. Zones can also act independently in considering and advocating on regional issues.

State Council is the decision-making, representative body of WALGA, responsible for sector-wide policy making and strategic planning.

The relationship between State Council and Zones is critical as it underpins WALGA's advocacy on behalf of Local Government at the State and Federal Government levels. Zones have an integral role in shaping the political and strategic direction of WALGA.

Delegates are appointed to represent their Local Government on the Zone and make decisions at a regional level. Individual Zones determine how many Delegates represent each member Local Government and are responsible for electing a Zone Chair and Deputy Chair.

When a Delegate is appointed to a Zone, they become eligible to nominate for State Council. As this is an election year, November Zone meetings will hold elections for State Council representatives and Zone Chair.

There are no sitting fees or reimbursements paid to Zone Delegates. State Councillors are entitled to travel reimbursement related to meeting attendance and are paid an annual sitting fee.

The time commitment for a Zone Delegate varies from Zone to Zone. Zones meet five times per year (in February, April, June, August and November). Meetings run for approximately 90 minutes. Agendas are distributed a week before Zone meetings.

There are sixteen Local Governments in the Great Eastern Country Zone (GECZ).

The GECZ generally been held on the second Thursday of the month (in February, April, June, August and November) at 9:30am. Hosting of Great Eastern Country Zone has been held rotating between Kellerberrin and Merredin, however at the November meeting it may be considered to rotate around member local Governments to provide an opportunity to showcase their area.

Each member Local Government on the Great Eastern Country Zone is entitled to appoint two voting Delegates and as many Deputy Delegates as they see fit. It is recommended that the Chief Executive Officer be appointed as an additional Deputy Delegate where it may be beneficial, to ensure that representation from each member Local Government can always be achieved at Zone meetings.

At the November Zone meeting, an election will be held for the positions of State Councillor (one position) and Deputy State Councillor (one position).

The next meeting of the Great Eastern Country Zone is on Thursday, 13 November at 9:30am hosted by the Shire of Kellerberrin.

GECZ provides a valuable forum for member Councils to collaborate on issues of regional significance, share resources and knowledge, and contribute to WALGA's policy and advocacy work.

Participation ensures that the Shire of Narembeen has a voice in discussions and decisions that influence the local government sector at both regional and state levels.

As there are no membership fees applicable for the 2025/26 financial year, the Shire's continued involvement remains cost-effective while supporting regional collaboration and leadership development. Representation through appointed delegates ensures consistent advocacy and alignment with Council's strategic priorities.
